Getting the most from your new digital monitoring solution



## What is Monitor?

Linewize Monitor is a human-moderated digital monitoring solution that alerts designated school staff to students who may be becoming vulnerable based on their activity on school learning devices.

With its powerful pattern analysis capabilities, Monitor identifies potentially concerning activity early, giving you visibility into escalating behaviours and enabling timely intervention and support.

Designed to cut through the noise, Monitor provides schools with clear, actionable insights, helping you proactively protect students throughout their digital journey.

Data is stored at Azure (Microsoft) data centres in the UK/EU and encrypted to AES256 levels in transit and at rest. No personally identifiable information (PII) is transferred outside the UK/EU.

## What is Smoothwall?

When you log in to your Monitor instance, you may notice the branding references Smoothwall by Qoria. Smoothwall was acquired by Linewize in 2022. As we work towards unifying all our solutions under the Qoria brand, the Smoothwall branding remains in place for now.

## Alerting Profiles

Alerting Profiles are customisable rules that manage alerts generated by Linewize Monitor. Schools can configure these profiles to suit their specific needs:

### Single Alerting Profile

Some schools use a single profile that directs all alerts from monitored users to a shared pool of Safeguarding contacts. Each contact in the pool receives alerts and has access to view all raised alerts.

### Granular Alerting Profiles

Other schools require more granularity, assigning alerts to different groups of Safeguarding contacts or designating specific individuals—such as Heads of Year, key stakeholders, or members of Wellbeing and Leadership teams—to receive alerts for the students they oversee.

Alerting profiles can be customised, updated, or created at any time.

## Monitor Event Types / Risk Categories

Linewize Monitor assesses content generated on a student's device and defines risk events based on the following 9 key risk categories.

## Monitor Risk Levels

Monitor Risk Levels are defined individually from 1 (low) through to 5 (high/maximum).

If there is imminent risk to life a phone call to designated school contacts will be made.

Linewize Monitor offers different levels of permission and visibility based on role requirements. Each user can only occupy one role within the Monitor platform. Most schools will allocate the "Safeguarding contact" level for non-IT staff who need visibility over student activity and alerts.
